A SF student who is approved to be a Epicurean Kitchen Intern will abide by the following rules and guidelines at all times while working in the kitchen.

Behavior will always reflect:

- Respect to Epicurean Staff and all Schoolwide Community daily
- Follow through with all safety expectations of self and others daily
- Polite attitude while serving the students and adults (SMILE) daily

Kitchen Expectations and Regulations

- Sign in on attendance worksheet daily for every work shift
- Closed toe shoes are to be worn, absolutely no sandals, skirts Must not be rolled and at appropriate length even when wearing leggings!
- Hair nets and gloves to be worn at all times
- Do not eat on the serving line
- Do not bring friends into the kitchen to visit with you
- Do not hang out in the kitchen outside your work shift

Activity Description

- Student Intern will be trained and supervised by Epicurean Staff
- Light kitchen duties included (dishwasher, stocking and serving) without the use of knives and clear of hot surfaces with the exception of the serving from the steam table
- Students will receive one free meal for each shift worked that day

Parent Agreement Consent

I/we, the undersigned parents or quardians of the participant named on this form give permission for my/our child's participation in the St. Francis Catholic High School activity referred to on this form.

- I/we agree to direct my/our child to cooperate and comply with all reasonable directions and instructions from St. FrancisCatholic High School staff or adult volunteer leaders.

Accordingly, in consideration for being permitted to participate in St. Francis Catholic High School activities, to use the equipment provided, and to enter the premises and facilities of St. Francis Catholic High School and the Diocese of Sacramento, for any purpose including observation of and participation in activities, the undersigned parent or guardian, for him or herself and any successors in interest, and on behalf of the student, agrees as follows:

- To release, waive, discharge, and promise not to sue the Roman Catholic Bishop of Sacramento, a corporation sole and St.Francis Catholic High School, its affiliated entities, employees, agents, and volunteers (the "Diocese") from all liability for any loss or damage, and any claim or demands therefore on account of serious or mortal injury to the body, injury to psyche, or injury to property of the student, or to undersigned parent or guardian, whether caused by negligence or other conduct by the Diocese while the student, parent, or guardian is participating in St. Francis Catholic High School activities or in, upon, or about the premises of the Diocese or any of its facilities or equipment.
- To indemnify and hold harmless the Diocese from any loss, liability, damage, or cost it may incur due to the presence of the student, parent, or quardian in, upon, or about the premises of the Diocese, its facilities or equipment, or while participating in any St. Francis Catholic High School activities whether caused by the negligence of the Diocese or otherwise.
- That he or she has read this Consent Form and agreement and voluntarily signs it, and that no oral representations, statements, or inducements apart from the contents of this Form have been made.
