

# What is St. Francis High School MOCK Trial? (from http://www.scoe.net/law/)

The Mock Trial competition simulates a trial-level proceeding in which students portray pre-trial counsel, prosecution and defense attorneys, witnesses, court clerk, courtroom artists, courtroom journalist, and bailiff before a presiding judge and 2-3 scoring judges.Student legal counsel is scored on how well they execute their case. The Courtroom Art competition sees student artists create courtroom sketches for scoring. The Courtroom Journalism competition sees students write an account of their own team's competition. All students who participate acquire a working knowledge of our judicial system, develop analytical and communication skills, and gain an understanding of their obligations and responsibilities as participating members of society. The Sacramento area has hosted the annual *Gordon D. Schaber* (GDS) Mock Trial competition since 1979.

#### The Case

Each year, the Constitutional Rights Foundation (CRF) creates and produces a new set of Mock Trial materials based on an important issue facing America's youth. The materials include a hypothetical criminal case (including summaries of case law, witness statements, official exhibits, and simplified rules of evidence), lesson plans on the central issues in the case, and competition rules and guidelines. #### The Students

The Mock Trial competition actively engages approximately 400 student-participants from 25 Sacramento area high schools. Students actively experience the excitement of working in teams, exchanging ideas, setting goals, and examining issues while interacting with positive role models from their communities. By studying the case and preparing strategies and arguments for trial, students also develop presentation skills, analytic ability, and team cooperation. Teacher- and attorney-coaches conduct practices, scrimmages, and prepare students for competition.

#### The Competition

Cases are released to all California counties in September. The GDS Mock Trial competition occurs in early spring, and includes multiple rounds of trials. The first-place team advances to the *StateFinals* in March. In May, the winner of the state competition represents California at the annual National High School Mock Trial competition, involving teams from 54 states and territories.

### Costs to Participate in SFHS Mock Trial

- OPTIONAL \$35 for team tee-shirt. (MT students may purchase team shirt to wear on Fridays).
- Students on the Mock Trial team must procure and study "*In Our Defense*" by Ellen Alderman & Caroline Kennedy (ISBN 0-380-71720-4)
- Students on Mock Trial rotate obligation to provide healthy snacks at weekday practices. This comes to approx. \$20 per snack duty. (Estimated four snack duties per student.)

#### **Responsibilities of SFHS Mock Trial Team Members**

- Mock Trial students meet every Monday and Thursday, 3:15-5:00pm in room 502 starting Sept. 8<sup>th</sup> plus additional weekend scrimmages (dates TBD). Scrimmages meet in the SF library on Saturdays, 9am till Noon.
- Mock Trial students complete 4-6 hours of homework per week. This work involves studying our case file, practicing your role, studying in the field of constitutional law, reading "*In Our Defense*," memorizing witness statements, honing attorney questions and opening/closing statements, researching legal precedence, and practicing courtroom delivery.

#### Grading

- Students receive 25/25 points for full participation at each weekday practices, 100/100 points for full participation at weekend practices and at competition rounds. Points deducted for arriving late, leaving early, and showing up unprepared.
- Students will be quizzed twice on specific readings from the book "In Our Defense." Each quiz carries a weight of 100 points.
- Students will be docked points for falling behind in trial statement preparation and witness statement memorization.
- A student who wears inappropriate attire at a scrimmage or competition round will be docked 100 points. (Students will be told exactly what to wear and what not to wear.)
- A student may request one optional project worth +100 extra credit points towards their MT grade.

## SF Mock Trial Team Tryouts Held Aug. 26<sup>th</sup> and Aug. 28<sup>th</sup>, 3:15-5:00pm in Rm 502

- Every position on the SFHS Mock Trial academic team is open. All students wishing to join the team must attend *one* tryout (either Aug. 26<sup>th</sup> or 28<sup>th</sup>). The team consists of approximately 18 students.
- Bring your signed contract (below) to one tryout event.
- Your tryout process differs based on which team role you want (described below). If you are invited to participate on the team, you may be assigned to any role per coaches.
- Your tryout will be observed by teacher- and attorney coaches, and will be video recorded.
- A Mock Trial General Info session will be held August 19th after school in room 502.

TRYOUTS: PROSPECTIVE STUDENT ATTORNEYS. If you wish to join the team as a prospective student attorney, the following paragraph describes your tryout process.

Bring your completed application to one tryout event. The back of this packet contains a hypothetical case file fact situation. Choose to portray either a prosecution or defense attorney.

Prepare a 3-5 minute opening statement to present in front of teacher- and attorney coaches. Present as if you are either defending Adrian Vega or prosecuting Adrian Vega. You may refer to your notes but do not simply read your statement. SF Mock Trial teacher-coach and attorney-coach will observe your opening statement. The team looks for confident public speaking, excellent volume, a touch of passion, an organized, flowing argument and sensible delivery of points. Sample opening statements follow at back of packet. You may use these statements, or incorporate them into your own statements, or refer to these statements when speaking.

TRYOUTS: PROSPECTIVE STUDENT WITNESSES. If you wish to join the team as a prospective student witness, the following paragraph describes your tryout process.

Bring your completed application to one tryout event. Following at the back of this packet are witness statements. Select **one** and memorize the details. At tryouts, you will roleplay your assigned witness role, including mannerisms, and answer questions as if you are testifying in a court of law. You may refer to your notes and to the actual witness statement. You will present in front of teacher-coach and attorney-coach, who will question you as if you are testifying. The team looks for empathy, confident speaking, memorization skill, acting ability, and a comfort level with questioning.

TRYOUTS: PROSPECTIVE COURTROOM ARTIST. If you wish to join the team as a

prospective courtroom artist, the following paragraph describes your tryout process.

Bring your completed application and necessary art suppliesto one tryout event. Sketch what you see. The drawing must be on 11" X 14" paper, in horizontal format, using any dry medium. Artists must supplypaper and mediums. Take as much time as you need. (A tryout event usually lasts two hours, but you are allowed to take your work home and submit it the following day to the SF Mock Trial teacher-coach). Your sketch



must be done in color. If you will be using charcoal or pastel pencils, use a spray sealer to prevent smudging. In the event multiple sketches are submitted, the SF Mock Trial teachercoach may solicit an opinion from the SF Art Dept.The adjoining picture is an example of a Mock Trial Courtroom Artist's sketch.

TRYOUTS: PROSPECTIVE COURTROOM JOURNALIST. If you wish to join the team as a prospective courtroom journalist, the following paragraph describes your tryout process.

Bring to one tryout event your completed application and a sample of your writing for the teacher-coach. This can be an article, journal entry, book report, reflection, essay, creative short story, or similar short work. The teacher- and attorney-coach will ask questions on your background and expertise. The team is looking for clear, concise writing, proper use of grammar and correct spelling, comprehensible and clear flow of thought, organized paragraphs, and advanced vocabulary. In the event multiple writing pieces are submitted, the Mock Trial teacher-coach may solicit an opinion from the SF English Dept.

Sample Prosecution Attorney Opening Statement

Your Honor, the evidence will show through the testimony of the witnesses that the defendant is guilty of hitting the victim, Cameron Douglas, and running.

On the night of Thursday, April 19, 2012, the defendant and her Italian foreign exchange student competed in a swim meet, and they won. To add onto this victory, the defendant was noticed by a scout from her dream school. That night, still exceptionally jubilant from her victories, Adrian got in the car and drove home. She was distracted by her happiness, and constantly texted her friends and family about her victory while driving. While she was distracted, she ran the stop sign between Skyline and Grand and hit what she thought was a mere bump in the road. However, she would later discover that it wasn't a bump, but the victim: Cameron Douglas. She refused to pull over despite Toni's incessant pleas. She slowed, but rather than stopping, she continued to drive. Although, after hitting Mrs. Douglas, she stopped texting: She finally conceded to the fact that it was too much for her to drive and text all of her friends at the same time.

When they got home, the defendant decided to walk around for a bit and cool off. While she was gone, Officers Wright and Jackson spoke to Toni about the accident. They also noticed scratches of turquoise-colored paint (the color of Decamp's bike) on the left front bumper where she hit Dallas. Later, the officers spoke with the defendant. When the officers suggested to the defendant that she was a suspect for the crime of a hit and run, she responded, "It was a bicyclist?! I am so sorry. I could never forgive myself!" The Officers promptly arrested her.

In this case, the circumstantial evidence is unequivocally compelling. Dallas Decamp will testify that she had seen the defendant driving recklessly around town on multiple occasions. She will also testify that when she was hit, she looked up and saw the defendant's face as she was sitting in the driver's seat. Mrs. Liu will also testify that she retrieved a partial license plate number that matched the Vega's Bueller. She was also able to describe the defendant's clothes. Her description matched the description that Officer Wright will testify to seeing when she talked to the defendant. Mrs. Liu also noticed the glow of a cell phone screen. Most importantly, Mrs. Liu will testify that after hitting Mr. Decamp, the defendant slowed noticeably indicating her awareness that she had hit something. But, she continued to drive, explicitly implying her conscious choice not to face her crime.

Due to the undeniable veracity of the circumstantial evidence, you will be duty bound to find the defendant guilty of Failure to Perform her Duty Following the Accident.

Sample Defense Attorney Opening Statement

Your Honor, the evidence will show that my client, Adrian Vega, is not guilty of a hit and run.

On the night of April 19, 2012, Miss Vega competed well in a swim competition. Miss Vega is a dedicated swimmer. After the meet, my client was approached by a scout from her dream school, University of Los Angeles. Adrian was very excited and unfocused and felt it would be best if she didn't drive home. Ms. Vega asked if Toni de Luca would drive home. She did not think it would be a problem since they only fived five miles away. Further, although it appeared that Toni de Luca was upset with the attention my client received, Ms. Vega believed that wouldn't affect de Luca's driving. Unfortunately my client was wrong.

Aubrey Fox will testify that Toni has a history of bad driving and that Toni has a history of running stop signs, a fact that my client was not aware of.

As they drove home, de Luca was speeding and ran a stop sign at the intersection of Skyline and Grand. As they were driving, my client heard a crash and was curious as to what it was. Toni de Luca and Adrian Vega didn't even know they hit SOMETHING. Dallas Decamp will testify that the brake lights never came on the black car nor did they even slow down. They were unaware they hit anything. Toni kept driving and ignored the incident. Ultimately, my client made De Luca pull over since Toni was driving recklessly. Miss. Vega wanted Toni de Luca to pull over so she could drive the rest of the way home. When they returned home, Miss. Vega hurriedly parked her car askew. My client had lost her key and was unable to get into her house. So, instead of just standing in cold, Ms. Vega took a walk to clear her head.

When Ms. Vega got back home, she spoke with Officer Kelly Wright. Officer Wright had a conversation with Adrian Vega and will testify that my client was very cooperative.

## CALIFORNIA MOCK TRIAL FACT SITUATION

2 Hidden Valley is, for the most part, a calm and peaceful city. It boasts 90 3 4 acres of parks, sports fields, and trails — a much cherished relief from the 5 urban congestion just 30 miles south. Its high school, Hidden Valley High, 6 located on Skyline Drive, is renowned for its stellar swimming program. 7 8 On the night of Thursday, April 19, 2012, a large crowd congregated in 9 front of the high school. The Hidden Valley Highlanders had claimed 10 another victory, qualifying them for the California State Championship. As 11 the crowd celebrated the victory, a vintage 1961 Bueller GT left the school 12 at approximately 10:30 p.m. and headed northbound on Skyline Drive. 13 14 That night, shortly after 10:30, Cameron Douglas was riding a bright 15 turquoise bike from the northwest corner of Skyline and Grand toward the 16 northeast corner of Skyline and Grand. The intersection is controlled by a 17 two-way stop with stop signs facing north and south. 18 19 As Cameron crossed the intersection of Skyline and Grand, an automobile 20 struck Cameron with its left front bumper. Cameron was sent flying from 21 the bike and landed several feet away in the street. 22 23 Ouinn Liu, who lives near the intersection of Skyline and Grand, saw the 24 Bueller collide with Cameron's bicycle. Quinn ran to call 911. While 25 waiting for an answer, Quinn wrote down part of the car's California 26 license plate number, SLC86. 27 28 Officers Wright and Jackson arrived at the scene around 10:40 p.m. just as 29 Cameron was loaded into an ambulance and then taken to a hospital. 30 Cameron was treated at the hospital for several serious abrasions, a 31 shattered right knee, a cracked collarbone, and a moderate concussion. At 32 the scene, the officers began questioning witnesses. Quinn described the 33 vehicle and the driver's clothes and mentioned that there was a glow that 34 appeared to emanate from a cell phone screen on the driver's side of the 35 vehicle. 36 37 Wright and Jackson questioned Dallas Decamp, who also witnessed the 38 accident. Dallas confirmed Quinn's description of the vehicle. 39 40 After the investigation at the scene concluded, a police dispatcher 41 connected with a statewide computer system, searched all California 42 license plates with the information provided by Quinn. Of the two 43 possible matches, only one was for a car registered in Hidden Valley. That 44 car was registered to an address on Orion Boulevard to Oliver Vega, the 45 mayor's spouse. Mayor Angelica Vega was an outspoken politician and a 46 supporter of FADD, Families Against Distracted Driving. The Vegas have 47 only one child, named Adrian.

- 49 Officers Wright and Jackson arrived at the Vega home at approximately 50 11:05 p.m. and found a black Bueller parked in the driveway with one of
- 51 its tires over the front lawn. Wright verified that the license plate matched
  - 1 the partial plate provided by Quinn and felt the hood of the car, which 2 was warm even though the air was cold. Wright noticed a couple of
  - 3 scrapes of turquoise paint on the driver's side of the front bumper.
  - 4
    - The officers approached the house, rang the doorbell, and knocked, but
  - 5 6 there was no answer. After a couple of minutes of ringing and knocking,
  - 7 Toni De Luca emerged from the side of the house wearing a light blue
  - 8 Hidden Valley T-shirt.
  - 9

10 Wright and Jackson spoke to Toni about the accident. Toni explained that 11 the mayor's child, Adrian, drove them both home from a swim meet 12 earlier that night and may have hit something. After questioning Toni, the 13 officers allowed Toni to go back to the guest house. Jackson resumed 14 investigating the outside of the Bueller while Wright walked back to the 15 police car to radio for a tow truck. It was approximately 11:25 p.m.

- 17 Wright then noticed a figure walking toward the Vega home. It was
- 18 Adrian, wearing a white T-shirt and a cardinal and gold cap. Adrian
- 19 confirmed living in the Vega home and stated that the Bueller belonged to
- 20 Adrian's father.
- 21

22 Wright asked if Adrian wanted to talk about events from that evening. 23 Adrian told Wright that Adrian had competed successfully in a swim meet 24 that night at Hidden Valley High. Adrian also told Wright that a foreign 25 exchange student named Toni drove both of them home in the Bueller 26 and may have hit something. Shortly thereafter, Adrian made Toni stop

- 27 the car, and the two switched places for the remainder of the ride to Adrian's house.

30 After a few minutes of talking to Wright, Adrian was shivering in the cold 31 air and said, "Don't you think it's cold out here?" Wright offered to let 32 Adrian sit in the back seat of the patrol car and gestured to the open rear 33 door. Officer Wright's patrol car was a cage car. Adrian sat on the edge of 34 the rear bench seat, but Adrian's feet were outside on the ground. Wright 35 stood by the open door, a few feet away. Officer Jackson stood in the 36 yard, about 15 feet behind Officer Wright. Officer Jackson is a former 37 college wrestler and shot putter standing 6 foot 5 inches tall and weighing 38 250 pounds.

40 41 42 43 44 45 46 47 48 49 50	[Wright and Adrian exchanged pleasantries about swimming and Adrian's future. Wright then closed the rear door of the car and entered the driver's seat. The patrol car's back doors cannot be opened from the inside when shut. Wright asked Adrian to continue talking about what happened that night. Wright again asked what Adrian had done earlier that evening. Adrian repeated what Adrian had said before getting into the back seat of the car. By the time they finished their conversation, Adrian had been in the car for about half an hour. Officer Wright then said, "Well, we think that it's possible that you drove the car that struck the bicyclist on Skyline and Grand tonight."
1 2 3	Adrian blurted: "It was a bicyclist?! I am so sorry. I — I could never forgive myself!"]
2 3 4 5 6 7 8	Wright believed that Adrian had been driving the Bueller that struck Cameron. Wright arrested Adrian for the felony violation of California Vehicle Code Section 20001. At that point Wright recited <i>Miranda</i> warnings to Adrian.
9 10 11 12 13	Adrian was taken to the police station and booked at approximately 12:15 a.m. on Friday, April 20, 2012. After being there for an hour, Adrian called Taylor Berard, Adrian's private swim coach, and asked for help to bail out of jail.
14 15 16 17 18	The Bueller was taken to the police impound lot. As required by the Hidden Valley Police Department's inventory policy, the police conducted an inventory search of the vehicle. Among the things found in the car were a business card of the University of Los Angeles swimming scout under the driver's seat and Adrian's cell phone in the center console.
19 20 21	Officer Jackson's U.S. Army Reserve unit has been called to active duty in Afghanistan and will not be back for 15 months.

## 23 CHARGES:

- 24 The prosecution charges Adrian Vega with:
- 25 Failure to Perform Duty Following Accident: Death or Injury, a felony
- 26 (commonly referred to as "felony hit-and-run"). California Vehicle Code
- 27 Section 20001 (a).

## 29 PHYSICAL EVIDENCE

- 30 Only the following physical evidence may be introduced at trial. The 31 prosecution is responsible for bringing:
- 32 1. A faithful reproduction of Exhibit A, a diagram of the accident scene.
- 33 ALL reproductions should be no larger than 22 inches x 28 inches
- 34

## 35 STIPULATIONS

- 36 Stipulations shall be considered part of the record. Prosecution and37 defense stipulate to the following:
- At the time of arrest, there was sufficient probable cause to arrest
   Adrian Vega.
- 40 2. All physical evidence and witnesses not provided for in the case are41 unavailable and their availability may not be questioned.
- 42 3. Beyond what's stated in the witness statements, there was no other43 forensic evidence found in this case.
- 44 4. All witness statements were taken in a timely manner.
- 45 5. Due to a technical glitch, no messages or numbers could be retrieved
  46 from the Adrian Vegas' phone or the phones of Adrian's parents and
  47 friends.
- 48 6. Cameron Douglas' right knee is permanently damaged.

I currently live in Hidden Valley and have served on the Hidden Valley Police Department for 12 years. I have extensive experience in investigating traffic collisions and hit-and-run incidents.

When we arrived at about 10:40 p.m., the victim, Cameron Douglas, was being loaded into an ambulance for transport to a hospital.
	At the scene, Officer Jackson and I questioned a witness named Quinn Liu, who described seeing a hit-and-run incident. Liu had told us a black vehicle heading north on Skyline Drive ran the stop sign at Skyline and Grand and struck a bicyclist. Although Liu was not able to identify the person driving the vehicle, we were told that there was the glow of a cell phone screen on the driver's side and that the driver was wearing a white T-shirt and cardinal and gold baseball cap. Liu also gave us a partial license plate number, SLC86.
	We interviewed another witness at the scene named Dallas Decamp. Decamp confirmed that the vehicle was a vintage black Bueller and also mentioned that the victim had white "earbud" style headphones on (like those for an MP3 player) and was looking down when struck by the vehicle.
	Jackson radioed the partial plate information to dispatch for a search. Only one vehicle matching the partial plate belonged to a car registered in Hidden Valley. I immediately recognized the owner's name, Oliver Vega, the husband of the mayor, Angelica Vega.
	We drove to the mayor's house to look for the suspect vehicle. It was about 11:05 p.m. When we got there, we saw a black vintage Bueller parked in the driveway, but at an angle with one tire on the lawn. Because it was such a cold night, Jackson left the police cruiser engine running to operate the heater. We then checked the license plate on the vehicle: It was SLC8693 and it matched the partial Liu gave us. The hood was warm, which indicated that it had recently been driven. I spotted scratches of turquoise-colored paint on the Bueller's left front bumper. It appeared from the lack of dirt on the scratches of turquoise, compared to the dirt on the rest of the bumper, that the turquoise scratches were recent.

- 47 The porch light was on, and we knocked on the door twice, but there was
- 48 no answer. We then heard a noise and saw a teenager come out from the
- 49 side of the house. The teenager was Toni De Luca. Toni explained to me
- 50 that Toni was a foreign exchange student from Italy who lived in the
- mayor's guest house behind the main house. Toni was wearing a light 51
  - 24
  - blue Hidden Valley T-shirt. I asked about the car and about the accident. 1 Toni said that the mayor's child, Adrian, drove them both home from the
  - 2 3 swim meet earlier that night. Furthermore, Toni said that Adrian was
  - 4 driving and may have struck something when they were on Skyline, on
  - 5 the way home. Toni was not exactly sure where on Skyline it occurred.
  - 6

7 After speaking with Toni, Toni went back to the guest house. I saw 8 Jackson inspect the outside of the Bueller again while I went to the patrol car to call a tow truck. I opened the passenger-side rear door to the police 9 10 car, obtained some paperwork that was in the backseat, and sat in the front seat to make the call on the police radio. The back door remained 11 12 open as I made the call. When I finished, I looked up at the rearview 13 mirror and saw someone walking toward us along the side of the road. That person was wearing a white T-shirt and cardinal and gold baseball 14 15 cap. That matched Liu's description of the suspect driver. It stood out in 16 my mind as unusual that someone would be walking alone so late at 17 night.

18

19 I signaled to Jackson that I would talk to this person, and Jackson remained in the front yard by the Bueller. I called out to the approaching 20 21 figure and asked if it wasn't late for someone to be walking around. I asked, "Are you all right?" The person said "I live here" and gestured 22 toward the house. I asked for a name, and the person told me "Adrian 23 Vega." I asked if the car belonged to Adrian, and Adrian responded that 24 the Bueller belonged to Oliver Vega, Adrian's father. Adrian had just come 25 back from a walk and had lost Adrian's keys. I mentioned I was 26 investigating an accident from earlier that night. 27

I asked Adrian what Adrian had done earlier that evening. Adrian told me 29 that Adrian had just come home from competing in a swimming meet at 30 the high school. Adrian explained that Toni drove both of them home 31 32 from the meet. Then, Adrian told me that Toni was apparently upset and grabbed Adrian's hat and phone during the drive home. The two started 33 bickering when Adrian tried to get the hat and phone back. Suddenly, 34 Adrian felt a bump and feared they had hit something. Toni said that they 35 didn't hit anything, and Adrian made Toni pull over. Adrian was not sure 36 37 of the exact location but it was somewhere on Skyline after Grand. Then 38 Adrian drove the rest of the way back home. 39 Adrian shivered and complained about the cold. I offered that Adrian 40 could sit in the patrol car, since there was apparently no way to get into 41 the house or, for that matter, the Bueller. I pointed to the rear seat of the 42 patrol car rather than the front, because it is against policy to have anyone 43 but officers in the front seat in non-emergency situations. 44 45 46 [At that point, Adrian and I discussed Adrian's swimming and Olympic 47 aspirations. I was a big fan of the Hidden Valley's team and knew that Adrian was the star swimmer. I congratulated Adrian on the win. 48

49

50 After talking for a few minutes, I said, "It really is cold out here." I closed

51 the back door. I moved to the front of the car and sat inside the driver's

seat. The doors of the cruiser lock automatically; I did not tell Adrian that 1 2 they were locked, and Adrian did not ask about it. I again asked Adrian 3 what Adrian had done earlier that evening. Adrian repeated the same 4 story that Adrian stated earlier. 5 6 As our conversation continued, Adrian began answering questions with 7 nothing more than quick shrugs of the shoulders. Adrian told me that 8 Adrian was tired. I told Adrian that we thought that Adrian drove the car 9 that struck the bicyclist on Skyline and Grand. Adrian said, "It was a 10 bicyclist?! I am so sorry. I could never forgive myself!"] 11 12 I arrested Adrian. As I did so, the tow truck arrived. Jackson handled the 13 impound of the Bueller. We transported Adrian to the station for booking. 14 Later, during our inventory search of the car, I found a business card of a 15 swimming scout from the University of Los Angeles under the driver's 16 seat and a cell phone in the center console. I later learned the cell phone belonged to Adrian Vega. Due to a technical glitch, no messages or 17 18 numbers could be retrieved from the phone. The Bueller was dusted for 19 prints, but none of them were usable. 20 21 The day after the arrest I was able to take a statement from the victim, 22 Cameron Douglas, at the hospital. Cameron stated that Cameron thought 23 the driver of the vehicle was Adrian Vega and identified the car as a black 24 Bueller. Cameron also mentioned seeing Adrian speeding and driving 25 recklessly through the city on numerous occasions prior to the accident. 26 27 A few days after the arrest, one of Adrian's friends, Aubrey, came forward with information about Adrian. Aubrey was nearly positive that before 28 Adrian and Toni left school, Toni was standing by the closed door on the 29 30 driver's side of the Bueller. 31

- 32 My partner for seven years, Officer Jackson, is in the Army Reserves and
- 33 was called up to duty in Afghanistan.

WITNESS STATEMENT—Defense Witness: Adrian Vega 1 My name is Adrian Vega and I am 18 years old. I am a senior at Hidden 2 3 Valley High. I am on the Hidden Valley Highlanders Swim Team. Swimming is my life. I practice hard every day and dream of getting a 4 5 scholarship to compete at the university level. My dream school is the 6 University of Los Angeles. Both of my parents went there and both were  $\frac{7}{8}$ swimmers, so I'm hoping to continue the tradition. 9 On the night of April 19, the State Championship qualifying meet was hosted at Hidden Valley High. It was an even more important meet 10 because everyone knew that a scout for the University of Los Angeles 11 12 would be there. Everyone on the team was trying to get the scout's 13 attention, especially Toni. You could say that we were competitive with 14 each other. I think Toni's a great swimmer; I just think that I have more experience and skill. Regardless, it was obvious that we were both trying 15 to shine throughout the meet to get that scout's attention. 16 17 18 Our team won the most races that night. It was such an amazing feeling. 19 What made it even better was that the scout for the University of Los Angeles approached me after the meet and told me that I had solid talent. 20 I was given a business card with the scout's personal line and a cardinal 21 22 and gold baseball cap with the school's logo. I was ecstatic, but I couldn't say the same for Toni. Toni had been trying to get the attention of the 23 24 25 scout for the entire season but unfortunately didn't. Toni and I left the meet together. Toni drove my car because I was just 26 too excited to drive. I was in a good mood. I kept texting my parents and 27 friends about my meeting with the scout. We only live about five miles 28 29 from Hidden Valley High, off of Skyline Drive, so I figured it was OK for Toni to drive the Bueller. The car has a manual transmission. Looking 30 back. I feel stupid about letting Toni drive my car. My dad doesn't let 31 32 anyone but me drive that car, and he gave me explicit instructions not to let anyone else drive it. It's a vintage model and worth a lot of money. It 33 34 35 was a huge mistake on my part. I soon realized that Toni was driving too fast. I was worried because 36 Skyline is a really twisty road. My good mood went away. I figured that 37 38 Toni must have been a little upset and just wanted to go home quickly or something. I tried to break the awkward silence by talking about the meet 39 and about how Toni may be able to speak with the scout in the future. All 40 of a sudden, Toni snatched my hat and put it on, saying how I didn't look 41 good in the school colors. I was annoved. Toni kept talking about how I 42 didn't even perform well during the meet and didn't understand why the 43 scout went up to me. I was not about to argue so I just kept texting, just 44

- 45 trying to block all that negativity out. Then Toni grabbed my phone and
- started pushing random buttons, mocking me about how I'm so attached to my phone and how I don't listen to anyone. By this time, I was upset 46
- 47
- 48 49 and tried to get it back.
- 50 Before I knew it, I heard this loud crash in front of the car. It all happened
- 51 so fast, I wasn't able to make out anything in front of the car. Also, the

street seemed a little dark, like the street lights weren't all working or 1 2 3 something. I asked Toni if we hit something, but Toni just said nothing. I demanded that we stop, but Toni just kept going. After about a minute, I

4 5 finally made Toni stop somewhere on Skyline but north of Grand. We 6 switched places, and I grabbed my hat back. I do not know exactly where 7we pulled over. When we got home, I parked the car hastily and might 8 have parked it kind of crooked; I was in a hurry to get away from Toni. 9 Toni just went straight to the guest house behind our main house, not 10 saying a word to me. I looked at the scratches on the bumper of the car 11 and started panicking because it looked like we did hit something. I didn't know what to do. My parents were gone for the weekend and left me in 12 charge of everything. I knew they would be furious.

13 14

15 I had to get myself together, so I took a quick walk to collect my thoughts. Somewhere along the street, I noticed my keys were missing. They must 16 17 have fallen out of my pocket. I was trying to retrace my steps to find 18 them. That's when I saw the police at my house.

19 20 One of the officers, Officer Wright, told me they were investigating an 21 accident from that evening. Wright started asking me questions about 22 what I did that evening. I told the officer everything stated above about swimming in the meet, Toni's driving, our arguing, the loud crash, and 23 24 then switching places before coming home. I told Wright about wanting to 25 clear my head by taking a walk. I was tired and cold from the meet and 26 27 my walk so all I wanted to do find my keys and go to sleep.

28 I complained about the cold night air, and the officer suggested that I sit 29 in the back seat of the cruiser, so I did. I talked to the officer for a few minutes about swim team. I could see the front yard while sitting there in 30 the backseat. I could see the other officer there, the only other one besides 31 Officer Wright. He had a towering frame. I would guess six foot four or 32 33 five — and big, too, like a wrestler. I noticed that the officer kept staring 34 at me, too, which made me so uncomfortable. I was scared, actually. I 35 remember thinking, I wouldn't want to get on that officer's bad side. I

- 36 wondered if they were going to let me go home that night.
- 37

38 [While the Officer Wright was asking me questions, suddenly, Wright shuts my door and gets in the car. I didn't know if the doors were locked 39 40 or not, but it didn't matter, I felt like I was already in big trouble. This is 41 where I started to get a little more nervous. Wright started asking more about that night, and even though I was really tired, I explained what had 42 happened again. When the officer told me that a bicyclist was hit, I felt 43 44 horrible. I felt so awful that my car had been involved in an accident. I knew right then and there that if I had been driving, this would not have 45 46 happened. I felt the need to say how sorry I was that someone did get injured, after all. I told the officer, "It was a bicyclist?! I am so sorry. I 47 48 could never forgive myself!"] 49

- 50 Before I knew it, I was under arrest and in a cell at the station. I had to
- 51 call my coach to bail me out. Do you know how embarrassing that is? I

1 said it before and I'll say it again: I didn't do anything wrong, Toni was

- 2 driving.
- 3
